The Stella Historic Llandudno Bed and Breakfast offers evening dog sitting services to allow you to enjoy some Llandudno human-only events during your stay, such as a show at Venue Cymru or a dinner at a restaurant that doesn't allow dogs.

The Stella's dog sitting service is legally licensed by Conwy Council, SAJ/Lic No. CBW16.

A copy of this license is on page 4 of this document.

The Stella's dog sitting service is offered daily in the evenings by Kristin, The Stella's proprietor, in her private living quarters and rear backyard. This service is only offered to overnight guests who are booked into The Stella.

Please note: Per The Stella's pet policy, dogs may be left unattended in a guest bedroom for a short time, as long as their owner is still onsite. However, dogs cannot be left unattended in guest rooms when their owner leaves The Stella's premises. The Stella's dog sitting service is to thus facilitate human guests to enjoy some dog-free Llandudno activities during their stay.

Availability: This service is only offered to overnight guests who are booked into The Stella. The Stella's dog sitting services can only accommodate dogs(s) from one Stella guest room or Stella guest group reservation at a time. We strongly recommend that you arrange dog sitting services well in advance of your stay, to avoid any availability disappointment.

Location: Dog sitting services will take place in Kristin's (The Stella's proprietor) private living quarters, not in the B&B's guest rooms. Kristin's personal living quarters include a small backyard.

Rate: A non-refundable booking fee of £10 is required to secure a reservation for this service, paid in advance. Thereafter, payable upon pickup of your dog(s) after the dog sitting timeslot, the following price scale applies:

- £5 per hour, or part thereof, in evening hours up to 9pm;
- £10 per hour, or part thereof, from 9pm onwards.

The £10 non-refundable booking fee must be paid in advance to secure a dog sitting reservation. The hourly time rate is payable upon collection of your dog(s) from the sitting service. This payment will be automatically deducted from the same card that was used to make the deposit, unless otherwise arranged.

T&Cs: All guests participating in The Stella's dog sitting service will need to read and sign a contract waiver at the time of the dog's/dogs' acceptance into The Stella's dog sitting service. This contract waiver is detailed on the pages 2 and 3 of this document.

I understand that I am solely responsible for any harm caused by/to my dog(s) while my dog(s) is/are in the care of The Stella and release The Stella of any liability arising from my dog’s attendance and participation of dog sitting services. All dogs are cared for by The Stella without liability on The Stella’s behalf for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other dogs, or property by said dog(s), or for other unavoidable causes. I accept that if my dog causes any excessive damage to The Stella that I will be responsible to pay for repairs.
